## FCPD Officer Charged with Assault Against Community Member

Colonel Edwin C. Roessler Jr., Fairfax County Police Chief: 'These acts are unacceptable.'

he body-worn camera video I am releasing shows a Fairfax County police officer deploying force in violation of our use of force policies ... They are criminal acts which violate our oath of office, and they ignore the sanctity of human life," said Colonel Edwin C. Roessler Jr., Fairfax County Police Chief the day after one of his officers deployed an "electronic control weapon," multiple times on an African American male who did not appear to be a threat. In a released video, the officer is shown using the weapon numerous times and in one instance with his knees on the man's back, the officer tases the man's neck. The victim calls out, "I can't breathe."

Fairfax County Police Officer First Class Tyler Timberlake, assigned to the Mount Vernon District Station for eight years, was charged with three counts of misdemeanor assault and battery, on Saturday, June 6, at the direction

According to police, officers responded to a call for service around 1:30 p.m. Friday, June 5, involving a man in crisis wandering in the roadway. As other officers attempted to de-escalate the situation working with paramedics to help get the man into an ambulance, PFC Timberlake arrived and used unacceptable force. Based on this action, Colonel Edwin C. Roessler Jr., Chief of Police, initi-

ated criminal and administrative investigations.

The day after the incident, shortly before 11:30 p.m., Roessler hosted a press conference. He along with Steve T. Descano, Fairfax County Commonwealth Attorney and Jeff McKay, chairman of the Fairfax County Board of Supervisors updated the community on the investigation regarding the inappropriate use of force and the deployment of the taser that occurred in a Mount Vernon neigh-

Descano verified that the Commonwealth had filed three different charges of assault and battery against Officer Timberlake, and as a result, he faced up to 36 months in incarceration.

"First, we will seek justice in this case ... Second, I cannot overstate the value and role that body-worn cameras have played in our investigation into this matter ... and lastly, this county, Fairfax County is our home, and we hold ourselves to a much higher standard than what we see in this video ... We will not tolerate this."

The Mount Vernon police district has body worn cameras because it was part of a pilot study, but the Board of Supervisors recently defunded plans to expand the body worn cameras to the rest of the

## Overlooked Primary Three Republicans on the ballot this month in primary for U.S. Senate.

on't look now, but Virginia is in the closing days of a primary. You might not have heard about it because of the global pandemic and the economic crisis. But buried beneath all the headlines about police brutality and racial injustice, Republicans are about to decide which candidate they want to appear on the ballot this November against incumbent U.S. Sen. Mark Warner. Many Republicans are struggling to figure out which candidate they are going to support in an election that almost seems like an afterthought in the midst of everything else that's going on right now. Even though Warner narrowly won his last reelection to Ed Gillespie six years ago, he seems to be in a solid position now.

"This is beyond an uphill race for any Republican running, especially candidates who have never held elective office and have no name recognition," said David Ramadan, a former Republican member of the House of Delegates who now teaches at George Mason University. "Mark Warner wins this one with a landslide."

Campaign finance records show Warner has more than \$8 million cash on hand. By contrast the three Republicans in the race are struggling. Daniel Gade of Mount Vernon has been the most successful, raising about half a million dollars. Thomas Speciale of Woodbridge has raised \$80,000. And Alissa Baldwin of Lunenburg County has raised less than \$8,000.

"Warner is going to run ahead of the Democratic ticket, maybe not by as much as he would historically but he'll outpoll the Democratic presidential candidate," said Ben Tribbett, Democratic political strategist. "For the Republicans to have a chance at winning the Senate race, they need Donald Trump to carry Virginia. And I don't think many people think that's going to happen, including the Trump campaign, which is not investing here."

"I view this run as an extension of my military service," said Gade. "For far too long, there are people in these political positions who are serving themselves or serving their parties and too few of them are serving the Constitution."

Gade says Warner has done little for Virginia, focusing instead on being a "reliable rubber stamp vote for his party." If elected, he says, he would support legislation that would give veterans the ability to use their VA benefits anywhere rather than limiting them to VA hospitals and clinics. He says he would also support the REINS Act, a proposal intended to cut down on regulation by requiring congressional approval

The Republican primary is June 23. The deadline to submit an application for an absentee ballot is June 16.

THOMAS SPECIALE, 51, is an intelligence officer for the Director of National Intelligence as a government contractor.

A native of Peoria, Ill., he has a bachelor of arts in political science from Illinois State University and a master of arts in international relations from American Military University. He enlisted in the Army in 1987, and he's served

on active duty or in

the Army Reserves since then except for the time he was in college. He's currently in the Army Reserves, where he serves as a human intelligence technician.

"Our country is being torn apart by hyper-partisanship and lies by career politicians, and ultimately there is a very real threat of socialism emerging in the United States," said Speciale. "Democrats want to do away with the Electoral College. They

> want to seize people's firearms. And they want to tamp down on what they call hate speech, which is any speech they don't like."

Speciale says Warner works for the Democratic National Committee instead of Virginia, raising money in New York, California and Florida rather than focusing on Virginia. If

elected, Speciale says, he would advocate for strengthening Second Amendment rights by eliminating so-called "gun free zones" and reducing requirements for gun owners to have concealed-carry permits in multiple states. He says he wants to "re-invent" the Department of Education, but he was unable to provide any specific details other than "hold schools accountable" and "hold teachers accountable." One the issue of immigration, Speciale supports reforms that are outside of the current Republican mainstream — allowing DACA students to receive student aid through the CARES Act, for example, or supporting a path to citizenship for undocumented immigrants.

"I don't think it is logical to think that you are going to evict 30 to 50 million illegal immigrants that our feckless leadership in the past have allowed to move here," he said. "And if you won't give me immigration reform, we'll have to build a wall."

He says he would have voted for the CARES Act, although he disagrees with the additional \$600 weekly benefits for people collecting unemployment insurance during the greatest economic crisis since the Great

Ultimately, though, he believes COVID-19 is what he calls a "fake pandemic" because he believes the original estimates for fatalities were overstated.

"I believe it's psychological terrorism," he said. "This is nothing more than a new flu."

ALISSA BALDWIN, 42, is an adjunct professor at Longwood University and a civics and economics teacher at Nottoway Middle School in Crewe. A native of Manassas, she was raised in Nokesville and Lunenburg. She has a bachelor of arts in political science and leadership studies from the University of Richmond and a master of science in educational leadership from Longwood University. She was a paralegal for several years before switching careers to become a high-school history teacher.

"I have gotten to a point where I'm so frustrated with the career politicians and the liberal progressive push on so many issues I hold near and dear, like life and liberty and gun rights," said Baldwin. "So I just decided to live my teaching and enter the race as truly a political outsider, someone who cares about people and is used to bringing people together to solve tough problems."

Baldwin says she would offer a contrast to Warner on issues like abortion, taxes and guns. If elected, she says, she would champion federal legislation that would outlaw the ability of business owners to prohibit firearms in their stores. On the issue of abortion, she is in favor of outlawing it even in cases of rape and incest. On the issue of education, she says she wants to dismantle the federal Department of Education using a phased approach that transfers all its operations to the states.

"They've actually created a lot more problems for teachers and created more inequity in the schools because of their funding formula and their regulations, which are actually unfunded mandates," she said. "It's quite burdensome on local school divisions in rural communities and urban communities that don't have the tax base for local matching funds."

Baldwin says she would have voted for the CARES Act, although she says she would have pressed for increased means testing to limit stimulus checks to people who are most in need rather than the widespread program that was approved by Congress.

"I don't believe that anyone who is here violating our rule of law should receive federal benefits," she said. "You are entitled to protection of your rights under our Constitution. But not benefits."

## The Time to Act is Now

r. Martin Luther King Jr. once said that "a riot is the language of the unheard." The centuries-long pain and suffering of black communities across this Commonwealth and our nation is clearer now to majority whites than ever before. Now, finally, we must dismantle the racial inequities that led to the tragic deaths of George Floyd, Ahmaud Arbery, and Breonna Taylor, inequities that should have been eliminated decades ago. The murderous 8 minutes and 46 seconds of Officer Chauvin's knee in Mr. Floyd's neck has shown white Americans what America's black citizens have endured all along. The time for action is now.

It is time for white citizens, who as a race have never endured this treatment, yet benefit from white privilege, to act. It is time for all of us who want to do the right thing and truly demand equity, but are unsure of what to do to move forward against four hundred years of institutionalized racism to speak out. The quote I remember best from Dr. King was his admonition, seemingly, to me: "In the end, we will remember not the words of our enemies, but the silence of our friends."

As your elected official, I am duty bound to try to change our laws after listening and learning, especially from black leaders in our community as we act together to dismantle the broken system that led to the deaths of George Floyd, Ahmaud Arbery, Breonna Taylor, Rodney King, Eric Garner, among countless other black and brown citizens. Closer to home, we can add to that list 25-year-old

Bijan Ghaisar, who was shot multiple times with impunity by the U.S. Park Police, without facing any accountability, on a quiet Tauxemont community street two and one half years ago.

We cannot be complacent with a return to normalcy. The sta-

tus quo was never equitable for black Americans, was it? We will try harder, and we will make our society more just and fair. Racism is a systemic problem. We each have a personal duty to call out racism wherever we see it in our daily lives, and to actively consider our own behavior through an equity lens. I am encouraged to see so many white youths around the country and in our own Mount Vernon community this past Friday evening, standing up and using their privilege to march down Richmond Highway in solidarity with black Americans to denounce racism in all its forms.

To all others, I need you to listen, learn, read books by black authors, donate your time and your money if you can, and even to attend peaceful demonstrations (using your masks and maintaining social distancing inasmuch as possible). As white allies, we must use our privilege to demand change and reconciliation for 400 years of suffering. One thing that is abundantly clear is that silence and inaction are not the answer and the time to act is now.

For all of us, watching the news has been heartbreaking and tough to take. Over the weekend, we witnessed yet another disturbing use of force incident in the Gum Springs community when a black man in obvious distress, who did

not appear to be a danger to himself or others, was tased by a Fairfax County police officer. The officer then put his knee on the back of this man's neck and tased the man additional times as he lay face down in the street and cried out that he

couldn't breathe. While I commend Fairfax County Police Chief Roessler and Commonwealth Attorney Descano's quick response in arresting and charging the officer with assault and battery, this incident shows that we have a police officer here in our community who is too quick to escalate the use of force, and just how critical bodyworn cameras are for transparency and holding our law enforcement accountable.

As both a member of the General Assembly and of the Virginia State Crime Commission, I stand ready to work with my colleagues and the Governor to recommend specific policy changes to ensure that law enforcement in Virginia is not just held accountable but is transformed and trained into peace enforcement agencies that emphasize de-escalation and nonlethal force, and employ empathy with a focus on mental health. It is important to work towards limiting the interactions between armed law enforcement officers and communities of color. Today, we call the police for everything, from welfare checks, to mental health crises, to seeing a person experiencing homelessness sleeping on a bench. While often well-intentioned, these interactions often have deadly consequences due to lack of training, as was the case for Atatiana Jefferson, who was shot in her own home by police during a check on her welfare. These situations could be better served by public safety employees who are trained social workers who are better able to diffuse a situation without the added dynamic of a deadly weapon.

We will eliminate those laws which contribute to the systemic racism in our Commonwealth that exist not just within the criminal justice system, but in healthcare, in housing, and so many other areas. We made some progress in this last General Assembly by passing legislation to remove all of the old Jim Crow language throughout the Virginia Code, and to allow localities to remove powerful symbols of hate, like the Robert E. Lee statue on Monument Avenue in Richmond and the statue of the Confederate soldier in Alexandria, that no longer stands after 131 years in the middle of South Washington street. We also eliminated another potent symbol, by no longer celebrating Lee-Jackson Day and instead making Election Day a state holiday, something I have long advocated for. Those monuments do not belong in our public places. They are totems to racism and must be dismantled al-

I hear — and encourage you to contact me — from constituents with hearts broken by witnessing police brutality, but now also with hope and legislative ideas on reforming our criminal justice system, as well as how to address better access to health care, workforce skills development, training for incarcerated black youth with real job skills, and affordable housing. There were many bills that I supported in past sessions like

I have spoken many times about the sanctity of life, opportunity and fairness for each of us and this officer's actions do not reflect these values, our policies, or the law. Our County police have hundreds of practices and policies that our community, the Ad Hoc Police Practices Review Commission and I have worked hard to put in place to create high standards.

## Fairfax NAACP: Police Must Be Held to a Higher Standard

#### Fairfax NAACP calls for major changes for FCPS following assault charge for FCPD.

n Friday, June 5, Fairfax Police responded to a call about a man in distress in the Mount Vernon area of Fairfax County. Body-cam footage and bystander video reviewed by the Fairfax NAACP appears to show a man in distress, however, he does not appear to be a danger to himself or others. FCPD Officer Tyler Timberlake arrived on scene and immediately deployed his taser. The first officer on scene, who spent the first few minutes of the tape trying to calm the man down, is confused and says, "Does he have warrants?"

Timberlake than put his knee on the back of this man's neck, while both cops and at least two EMTs piled on to the man as he cries out:

"Deedee, I can't breathe."

Timberlake used his taser on the man at least two more times while he was already facedown on the ground.

The Fairfax County Police and Commonwealth's Attorney moved swiftly to charge officer Timberlake with assault and battery, announcing the charges at press conference on Saturday night.

Fairfax NAACP President Sean Perryman:

"I commend Chief Roessler and Commonwealth At-

torney Descano for moving quickly to charge and arrest the officer that assaulted a man clearly in distress and in need of help. This latest video is a testament that Fairfax County is not immune to police violence. We already know that use of force is disproportionately used against Black members of the community.

"Although we saw the county move swiftly to arrest this officer, we do not know what the official story would be without body cam and bystander video. Most officers in Fairfax are not equipped with a body camera and the Board of Supervisors has chosen to delay the roll out of body-worn cameras.

"The community needs increased accountability and transparency for its officers. And we need to reduce the interaction of Black people with armed officers because we see time and time again that we are viewed as a threat. This incident should never have happened."

The Fairfax NAACP is working with individuals and ally organizations to develop a host of changes to the way policing is conducted in the county. Advocating for how police respond to people in mental health distress is just one such change, and we will be unveiling the full list of our proposals in the coming days.

The rally started on the stage with Greg Wright singing "Hallelujah To Our God," before one of the march organizers, Pastor Brown, took the microphone. "It's time to pool our resources and use our leverage. It is time," he told the crowd. "Thank you for being here, the time is now."

One of the speakers was Shirley Ginwright who said she marched with Martin Luther King Jr. and noted the similarities to now, but nothing has changed in a way, she said. This included education of African Americans, and noted the racial makeup of Thomas Jefferson School of Science and Technology. TJ didn't admit any black students for next year's class. "We need to change that now," she said.

When it came to Col. Edwin C. Roessler Jr., the Fairfax County Chief of Police, he got right to the point with the atmosphere at the police force. "It needs to change," he said.

Virginia Lieutenant Governor Justin Fairfax (D) got a round of applause when he talked about the collaborative effort with Governor Ralph Northam (D) to take

down some Civil War statues in Richmond. "We will no longer tolerate what that statue stands for," he said.

The crowd reflected the diversity of the community. Nearly everyone wore masks as protection from the coronavirus. Alice West came from Fauquier County with her church, and her Bishop Sharma Lewis. "I felt I needed to come out to support that," she said.

There were local families, and mother and daughter pairs in the crowd, including Cara and Catherine Stankewick from Mount Vernon. Catherine Stankewick will be a sophomore in the fall.

"It is very important, I saw the video of excessive force and started crying," she said. "It's very important to have our voices heard and lead to change, there's been too many that don't lead to change," she said.

Lianne and Grace Lafleur were there. Grace will be a senior at West Potomac High School in the fall. "I'm excited to have her take part in it," Lianne Lafleur said. Lianne Lafleur is a teacher at Stratford Landing Elementary School.

When the speeches were done,

the marchers were ready, with a drum beating and signs in hand. They were led by a few vehicles out to Richmond Highway, and headed north to Mount Vernon Square. Midway, they stopped for another set of speakers including Supervisor Dan Storck (D-Mount Vernon). Storck saw the video of the Gum Springs violence, and issued a response on his e-news. "I have watched the video and I am shocked, saddened and deeply troubled by this officer's actions," he wrote. "The actions of this officer do not reflect these values, our policies, or the law," said Lee District Supervisor Rodney Lusk, who spoke after Storck.

The officer, Tyler Timberlake, was charged with three counts of misdemeanor assault and battery. Timberlake has been an officer for eight years and assigned to the Mount Vernon District Station, police said.

Once at their destination, Mount Vernon Square, speakers included Queenie Cox, an activist with roots in Gum Springs. She was joined by school officials and church officials.

All of us will need to feel as they did the fierce urgency of now. All of us need to recognize as they did that change depends on our actions, on our attitudes, the things we teach our children. And if we make such an effort, no matter how hard it may sometimes seem, laws can be passed, and consciences can be stirred, and consensus can be built."

Chief Roessler said, "Our nation is righteously angry at the law enforcement profession as am I ... The Fairfax County Police department is engaged with its communities, and we value transparency, accountability and as evidenced by our civilian review panel." Roessler said the video erodes the public trust of police officers in the county and throughout the world. "These acts are unacceptable," Roessler said.

According to Roessler, the victim was treated at a local hospital and released. "I thank God through my prayers that he is alive and resting at home with his family. I've personally reached out to the victim and spoke with his mother to express my disgust with my officer's unacceptable criminal actions and assured her justice will be served. ... I plead with our community to understand they are seeing transparency and accountability. I will ensure the police department serves

Roessler said that in addition to the criminal investigation, he launched an administrative investigation. "The officer's horrible use of force shall be subjected to independent review by the Fairfax County police auditor," said Roessler. He added that all officers at the scene were relieved of duty, pending the outcomes of both the criminal and administrative investigations. Roessler said.

"[Timberlake] was relieved of duty and all his law enforcement authority." He noted that the administrative investigation would be swift; however, personnel regulations had to be abided for due process.

Supervisor Dan Storck, who represents the Mount Vernon District where the incident occurred helped to organize a march on Tuesday. "I am shocked, saddened and deeply troubled by this officer's actions," Storck said.

"The community needs increased accountability and transparency for its officers," said Sean Perryman, president of the Fairfax NAACP. "We need to reduce the interaction of Black people with armed officers because we see time and time again that we are viewed as a threat. This incident should never have happened."

The Fairfax NAACP is working to develop a host of changes to the way policing is conducted in the county, including how police respond to people in mental health distress. Fairfax NAACP will hold a virtual town hall on Facebook live with the Board of Supervisors and Roessler on Tuesday, June 16 at 7 p.m., where they will propose action on transparency and accountability locally.

Fairfax County Police most recent Use of Force Report for 2018 shows that while 9.7 percent of the Fairfax County population in 2018 was African American, police use of force incidents involved African Americans in 248 of the 510 cases, which is 48.6 percent of the incidents. FCPD has not yet released the 2019 report.

Police are currently working with a research team to study racial disparities in use of force incidents, said Chairman McKay in a general email sent on Saturday. Researchers from the University of Texas at San Antonio and the University of Cincinnati anticipate a report at the end of January 2021.





## Summer Blooms

## Heat tolerant flowers that add bursts of color to gardens and landscapes.

s spring flowers begin to wither under the heat and humidity of summer, the vibrant blooms that once graced yards and gardens begin to fade. It's during this time that landscapers and gardeners rely on a bevy of color rich flowering plants that are hearty enough to stand up to the relentless summer sun.

It's during this time that landscapers and gardeners rely on a bevy of flowering plants that are hearty enough to stand up to the relentless heat from the summer sun.

"There are many annuals that keep blooming and producing more flowers, so you have constant color and constant flowers throughout the summer," said Janet Shalestik, Plant Specialist, Merrifield Garden Center, Fair Oaks, Virginia.

"They can all be planted either in the ground or in containers."

One of the most popular is Lantana, which can be variegated in two-toned red and orange and Salvia, which can grow to be two to three feet tall. Both flowers attract hummingbirds and butterflies, says Shalestik. "Salvia are often purple and blue and sometimes red. What a lot of people like to do is put them containers on their patio, deck so they can see the hummingbirds and butterflies while they're sitting outside."

Orange and pink Begonias, Petunias in deep purple and fuchsia, towering Sunflowers and Zinnias with blooms that burst in colors like orange, pink and yellow and deep pink are also top summer picks, said Shalestik. "Zinnias can get nice and tall so people sometimes want to use them as a backdrop in their garden."

Summer-Flowering Vinca are a low-maintenance choice. "They're very heat tolerant, they don't have to deadhead and they're very deer-resistance," said Shalestik

"Hydration is key, especially for flowers that are planted in containers," said Janet. "It's important to water when it's hot and we're not getting much rain. We recommend watering in the morning so they're hydrated when the intense heat starts."

#### "The News of My Death ...

By KENNETH B. LOURIE

... is greatly exaggerated." So said Mark Twain. So said W.C. Fields. And so said Kenny Lourie. And the reason I am now saying it is because of what correspondence I received in my personal inbox accessed through my HMO's online site. What I received was a condolence letter (sort of a form letter, quite frankly), addressed to the Lourie family from my oncologist expressing his sadness at my "passing" and his "privilege to have participated in the care of Kenneth Blacker Lourie' (me). Then, a bit later in the day, I received a cellphone call from an unknown number (so I didn't answer it) but apparently, it knew me as a voice mail message was indicated. I entered my code and listened in associated shock as I heard my oncologist speak in a very heartfelt way about his "sadness" yet again concerning the death of yours truly. He spoke for nearly a minute, hemming and hawing and occasionally hesitating as if at a loss for words. Compared to the email, this message was personalized. Reading and then hearing what I have just written was an out-of-body experience of sorts, almost as if I was attending my own funeral and listening to the eulogies while standing off in the distance.

This experience was not totally unfamiliar to me. In fact, once before, pre-cancer, something similar happened though it was more curious than morbid. Scanning the Obituary section of The Washington Post, I noticed - for the first time, photos of the many of the deceased were a part of the page. They were located above the agatetype and mostly in black and white. Catching my attention as they did, I randomly went to the top right corner of the right-side page where I saw a photograph of an African-American man. Unknown to me except for one extraordinary fact. Printed below his photo was his date of birth: 9/30/54. The same as mine. It took my breath away. I have to tell you, seeing one's date of birth listed in the obituary section is a peculiar kind of the-future-being-now.

Subsequently, I was diagnosed with "terminal non small cell lung cancer, stage IV and given a "13 month to two year" prognosis. And though my presumptive death was not listed in the obituary section, its inevitability was implanted in my brain where it has been gnawing at me since late February, 2009. And for the last 11-plus years, as you regular readers know, I have ebbed and flowed with the varying medicines and protocols which have amazingly managed to extend my life way beyond my oncologist's expectations, and never once had I being given last rites, so to speak, or advised to "get my things in order." Until today,

After I thought a bit about what I had read and heard, a part of me drifted back in time to the 1999 Bruce Willis movie "The Sixth Sense" and whether unlike Haley Joel Osment, I was actually dead already. Being alone in my house with nobody to snap me out of my delusion, for all I knew, this is what death feels like. Nevertheless, I continued with my normal routine, presuming I was still alive and sure enough, it soon became clear that I was indeed still alive.

But my oncologist and maybe even my endocrinologist - with whom I have an appointment Monday, June 8th might think otherwise. And not that their thinking 'otherwise' will change their lives, but knowing what they think they know rather than what is actually true might blip their radar and cause some emotional misdirection. After all, they're only human and even though I might not be their most memorable patient, given my unexpectedly long life post diagnosis, I feel I'm not so easily forgettable either. 


